Dear Ms. Lorenzetti:

The Department of Environmental Protection (DEP) has reviewed the October 5, 2018, document titled Final Site Characterization Report for the release incident referenced above. This document was prepared by LaBella Associates, P.C. and submitted as a Site Characterization Report (SCR) by 25 Pa. Code § 245.310(a). You selected the Non-Residential, Used Aquifer Statewide Health Standard as the remediation standard for soil and groundwater.

DEP approves the SCR in accordance with Section 245.310(c)(2) with the following modification(s)/stipulation(s):

• As noted on page 7-1 of the SCR, groundwater flow beneath the subject property is to the southeast. Groundwater then assumes a northeasterly flow direction northeast of the subject property. This northeasterly flow is towards the Krenitsky residential property. Because of the mentioned groundwater flow toward the Krenitsky property, the Residential Used Aquifer Statewide Health Standard should be selected as the remediation standard for groundwater instead of the Non-Residential option.

A Remedial Action Plan (RAP) conforming to the requirements of Section 245.311(b) of DEP's Corrective Action Regulations, shall be submitted to DEP for review. Section 245.311(a) requires that the RAP be submitted within 45 days of your SCR submittal, or submitted within an alternative time frame as determined by DEP. Your RAP is due no later than May 1, 2019. Your RAP submission should address the modification(s) noted above.

Failure to submit a complete RAP within the alternative timeframe as determined by DEP may result in enforcement action.

Any person aggrieved by this action may appeal the action to the Environmental Hearing Board (Board) pursuant to Section 4 of the Environmental Hearing Board Act, 35 P.S. § 7514, and the Administrative Agency Law, 2 Pa.C.S. Chapter 5A.
