This was a defined Scope of Work bid and so price was the most heavily weighted evaluation criteria. The range in cost between the twelve evaluated bids was \$36,428.07 to \$69,556.00. Based on the numerical scoring, three of the twelve bids were determined to meet the "Reasonable and Necessary" criteria established by the Regulations and were deemed acceptable by the evaluation committee for USTIF funding. The claimant reviewed and selected the acceptable bid.

## The selected bidder was Alternative Environmental Solutions, Inc.: Bid Price - \$36,428.07.

The attached sheet lists some general comments regarding the evaluation of the bids that were received for this solicitation. These comments are intended to provide information regarding the bids that were received for this solicitation and to assist you in preparing bids for future solicitations.

## GENERAL COMMENTS REGARDING EVALUATED BIDS

- Bidders should provide a clear description of how the proposed work scope will be completed. The bid package should specifically discuss all tasks and subtasks that will be included under the fixed price contract, what specific activities are included in each task, and how the tasks will specifically be completed (i.e., explain how groundwater sampling will be conducted, what will be completed as part of the Supplemental Site Characterization Report, etc.).
- The proposed subcontractor mark-ups ranged from 0% to 15%. Please be aware that USTIF will not reimburse subcontractor mark-ups greater than 10%.
- Please include all requested information (insurance, qualifications, questions, cost spreadsheets, milestone schedules, etc.) in the bid submittal.
- Copies of quotations from all major subcontractors (including drilling companies and analytical laboratories) should be included as attachments in the bid package. Several bidders did not include any subcontractor quotes.
- Bid responses should include enough "original" language and thought that the knowledge and approach of the firm can be evaluated. The reason for this is that the bidders on the USTIF list are not pre-qualified and so the evaluation committee must evaluate the technical aspects of the bid and bidder.
